Runoff Mitigation Measures and Determining Hydrologic Soil Groups for the Enlist Herbicide Labels

The following is provided to assist applicators in complying with the runoff mitigation section of the Enlist product labels (Enlist One and Enlist Duo). The Nebraska Department of Agriculture (NDA) believes that compliance should not be too burdensome for most landowners and operators, however there will need to be communication between those individuals and the pesticide applicator if the applications are done by someone other than the landowner or tenant.

Applicators (both private and commercial) must know the Hydrologic Soil Group (HSG) for the soils on which they are applying the herbicide. HSGs are used to estimate runoff potential of a soil, and for these products they will be used to determine which mitigation measures a producer should have in place before applying them. The information below should be helpful in determining the HSGs and using that info for determining the minimum mitigation measures required. Once the HSG is determined for a field it should not change, and NDA recommends applicators keep a permanent record of the field's HSG for future reference.

For both Enlist labels, an HSG soil group A or B requires mitigation measures selected from the table provided on the label (Figure 1) to equal a minimum of four credits. For an HSG soil group of C or D, mitigation measures must be selected to equal a minimum of six credits.

For many sites, even with C and D soils, a combination of residue management and reducing the number of applications will be enough to comply with these directions for reducing herbicides in runoff. A relatively simple way to determine the HSGs at your application site is to use the USDA Web Soil Survey at <u>https://websoilsurvey.sc.egov.usda.gov/App/HomePage.htm</u> (Figure 2). Click on the green button labeled "START WSS".




Figure 3. Screenshot of the map for the Web Soil Survey.

This takes you to a map of the United States (see Figure 3). Click on the zoom icon (magnifying glass with a plus sign) and use the cursor to draw a rectangle around Nebraska or search for a specific address under "quick navigation" on the left-hand side.

A zoomed map of Nebraska will appear (Figure 4). From here, continue zooming your way toward your property by drawing increasingly smaller boxes until you recognize the field to be sprayed.

Once you zoom in to your property, click the AOI (area of interest) icon (circled in Figure 4 above) and use the cursor to surround the field you plan to spray.




Figure 5. The field to be sprayed has been selected as an AOI (area of interest).

Now you have captured your work area giving you access to soil data specific to that area. Your AOI should appear and be shaded like the example in Figure 5.




Figure 6. Example of a soil map for a hypothetical field to be sprayed.

Now you can click on the "Soil Map" tab at the upper left to create a soil map of your work area (highlighted by the arrow in Figure 5). Note the numbers within the polygons (irregularly shaped outlines) of the field you plan to spray and click on the corresponding soil series in the table on the left of the screen, as shown in Figure 6.




Figure 7. Identification of the hydrologic soil group (HSG) for the field.

In this example, there are several soil map units in this field, each corresponding to a map unit description in the box. Clicking on the hyperlinked text of each map unit will open a pop-up with additional narrative descriptions. Near the bottom of each narrative is a listing of "interpretive groups" including the HSG. Three of the four map units in this field are in HSG B (Figure 7).

Caution: While the Enlist label has an asterisk under the table that "defines" HSGs by soil texture, this is a generalization. Often a silt loam can be either HSG C or D, while a loam can be HSG A or C. While following the general guide on the label should suffice for label compliance, the most accurate method is to use the Web Soil Survey method outlined above to get site-specific data.

Additionally, some soils are listed in dual groups such as B/D. The first letter refers to the HSG in a drained condition, such as a field with a tile drain system, while the second letter indicates the HSG of the soil in its undrained, or natural condition.

Another consideration is what to do if your field includes multiple HSGs, as in this example. We are currently working to get a better understanding on this issue. For now, a conservative approach is recommended. To limit liability, NDA recommends using the most limiting HSG to calculate mitigation measures. In other words, if a field is interlaced with HSG A or B and C or D, calculate your mitigation measure score based on HSG C or D, which are more restrictive than A or B soil groups.




Figure 8. Example soil map with HSGs color-coded.

To get a map and table of the HSGs for your application area, you are just a few of clicks away. Follow the arrows shown below in Figure 8 in the numerical order indicated to get a color-coded map by HSG. That is: 1) click "soils data explorer" > 2) "soil properties and qualities" > 3) "soil qualities and features" > 4) "Hydrologic soil group" > 5) "view rating".




Figure 10. Example map with export or print button circled.

You can easily export a PDF copy of the map and table for later reference by clicking the "printable version" button in the upper righthand corner of your view (circled in Figure 10 below). If you have multiple fields or application areas, you can give each one a map title for reference, which may be useful to send to the applicator and/or landowner/operator.
